Executive Director's Report

As a provincial umbrella association, I acknowledge that BC is home to 198 First Nations. I would like to begin by expressing my recognition for the privilege that we have inherently acquired through working on the unceded ancestral territory of the Musqueum, Squamish and Tsleil-Waututh people and I give them my deepest gratitude.

Connecting our members with funders to influence policy and decision-making is a key function of AMSSA, and this year we had several opportunities to host extensive discussions and consultations. AMSSA planned and managed the logistics of an expanded National Settlement Council meeting called NSC Plus hosted in June 2018 in Ottawa, Ontario. We organized and hosted the BC Settlement and Integration Services Provincial Meeting in October 2018 so BCSIS-funded service providers could connect with sector colleagues and the government funders. As well, AMSSA organized a LINC Launch and Learn event, releasing a professional development tool to support LINC programs serving newcomers with diverse and complex needs, and the BC Call for Proposals Summit in collaboration with IRCC to consult with BC service providers regarding the 2019 CFP. Online learning continues to be one of AMSSA's strengths, and through webinars such as "Unpacking LINC Placement, Delivery and Assessment" and e-learning modules about topics such as Refugee Mental Health, AMSSA shared the knowledge of Subject Matter Experts with our membership and partners.

We have experienced increasing engagement from the Provincial government and capitalized on the opportunity to present Immigration for BC's Future: A Call for Action to Strengthen Newcomer Integration on behalf of the Immigrant Integration Coordinating Committee. Engagement has also increased at the federal level and funding to support organizations who deliver services to Migrant Workers came through a partnership with Employment and Social Development Canada. Through funding from Canadian Heritage, AMSSA engaged in a partnership with the Vancouver Immigration Partnership and BCIT to build a framework that puts organizational leadership and our experience as non-indigenous people in relation to Indigenous presence at the forefront of processes that bring knowledge to newcomers of the current and historical impacts of colonization.

On behalf of the AMSSA team and our Board of Directors, I wish to thank our funders for their generous support of our programs. We are so proud of the work that our membership accomplishes every year to impact the lives of newcomers and the communities that welcome them. I also wish to share my deepest gratitude to Jean McRae, our outgoing Board President for her dedication to AMSSA and our members, we wish you all the very best!


