Due to the arrival of new permanent residents and displaced Ukrainians in British Columbia, Canadians have been volunteering to temporarily host newcomers in their homes. United Way BC quickly took on the responsibility of providing criminal record checks to host families.

This Housing Assessment Tool is part of a training package and toolkit. The combined toolkit is the response of the BC Interior Refugee Response Team to outreach requests for these homes to match newcomers with safe homes that meet their needs.

Assessments are conducted by volunteers from cultural organizations and settlement agencies across the Thompson-Okanagan and Kootenays. The results of these assessments are compiled and shared with United Way BC, the Refugee Response Team's partner agencies and other stakeholders including the Ministry of Municipal Affairs.
